1. Applicant must be graduating from high school in spring 2017 and attending a college, university, or technical school fall 2017.
2. Applicant must be a primary member of Georgia Power Northwest Federal Credit Union.
3. Applicant must have a minimum 3.0 cumulative grade point average (GPA) on a 4.0 scale.
4. In order to be considered for this scholarship, the applicant must submit:
 - a. a complete application,
 - b. copy of your most current high school transcript,
 - c. copy of your acceptance letter to the college, university, or technical school you will attend, and
 - d. a 500 word essay on the provided topic.
5. Your completed application and essay must be received by the close of business on April 17, 2017. If your application is received after this date, it will not be considered.
